IN 2016, THE FOUNDATION MADE GRANTS TO 222 ORGANIZATIONS THROUGHOUT THE UNITED STATES, WITH THE MAJORITY LOCATED IN THE MIDLAND AREA. GRANTS SPAN THE BREADTH OF ALL THAT MAKES FOR A VIBRANT AREA INCLUDING ARTS, COMMUNITY, EDUCATION, ENVIRONMENT, HEALTH AND HUMAN SERVICE, RECREATION, AND YOUTH. THE GRANTS ARE DESIGNED TO FULFILL THE FOUNDATIONS MISSION OF PROVIDING PHILANTHROPIC LEADERSHIP TO STRENGTHEN OUR COMMUNITY BY FOSTERING COLLABORATION AND GIVING TODAY AND IN THE FUTURE.
