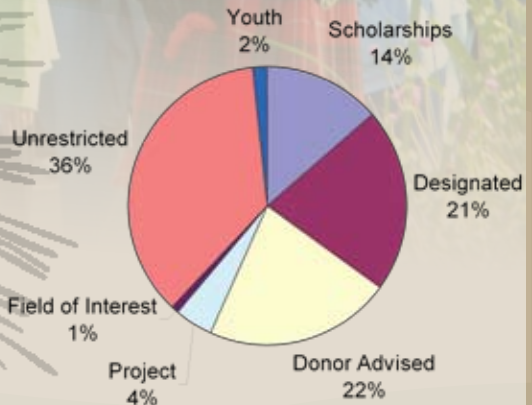

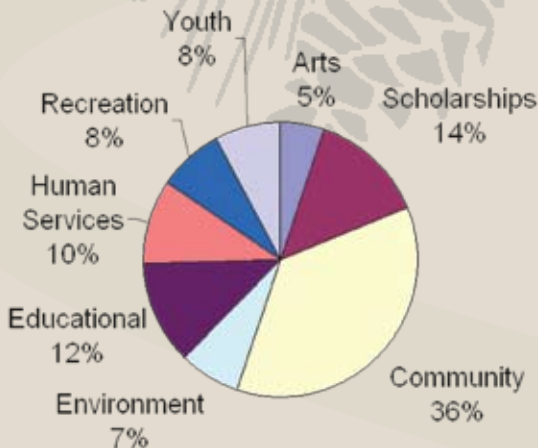

Coleman Community Clothing Closet

The Coleman Community Clothing Closet was located in the dim dark log cabin last year. In 2010, members of the community came together to move the location to the Middle School in order to provide a bright, clean and roomy space to present clothing to those in the community that need it.

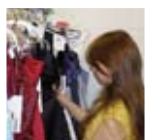


The Clothing Closet, managed and staffed with 100% volunteer labor, has been helping area families with clothing and household needs for over 20 years. By collaborating with the Public Schools, Railway Family Center, local contractors, local churches and city officials, the Coleman Clothing Center applied for and was granted enough funding to provide the building materials to improve the location and services to local families.

Old Grants See Great Results!

The Foundation funds new projects with hopes they will benefit our community and hopefully grow into larger projects. Three grants that were funded one time as initial start-up community projects have grown into successful annual events.

- The Jazz Trail was first held in 2009 in Midland. In 2011 it is spanning our entire region.
- Funded for the first time in 2009, the Tri-Kids Try Children's Triathlon is in its third year and growing in participation each year.
- Share the Memories, a program that makes sure young ladies get a gorgeous prom dress regardless of their financial situation, was funded in 2008. The program started in 2009 and has expanded to a regional program for 2011.

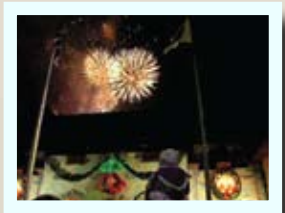
Senior Christmas Dinners

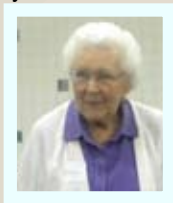
Midland is a community of people who care, of people who give. We try to recognize those who give back.

Giving Tree Awards

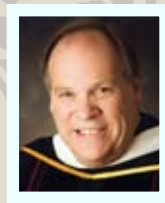

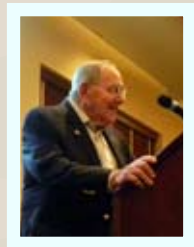
